We use your data to provide and improve the Service. By using the Service, you agree to the collection and use of information in accordance with this policy. - **What Data Does GADGLE Collect?**

- **When You Make an Account**

Gadgle stores information such as your name, email address and passwords so you can sign in, and it helps us verify your account if you call customer support.

- **When You Buy Products**

When you buy products from Gadgle website, we ask for information such as your name, address and phone number so we can get your order processed and shipped to you.

- **When You Sync Products**

When you sync your device, we collect data such as your IP address, sync time and date and battery level to help identify and resolve errors or syncing issues and to provide better customer support.

Gadgle will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy and no transfer of your Personal Data will take place to an organization or a country unless there are adequate controls in place including the security of your data and other personal information.

- **How We Protect Your Information**

- Our servers and your personal information are safeguarded by security measures such as firewalls and antivirus systems. Only authorized persons bound by strict confidentiality obligations can gain access to your personal information. These authorized persons will be subject to legal sanctions if confidentiality is breached.
- The passwords you provide are encrypted at the browser level and then protected during transmission using 128bits SSL. We will never be able to access unencrypted user password information. Gadgle Creative Technology Co., Ltd. takes all reasonable precautions to ensure the protection of your passwords and personal information against loss, misuse, disclosure without authorization, or modification; unfortunately, it is impossible for us to completely guarantee the safety of data transmitted over the Internet. Therefore, even though we strive to protect your personal information, we cannot ensure the
